7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Cavanaugh Building Corporation for the Pavilion Construction Project, for the pavilion at**
9 **the Summit County Children Services Administration Building, located in the City of**
10 **Akron, in Council District 4, in an amount not to exceed \$224,900.00, for the Executive's**
11 **Department of Administrative Services–Physical Plants, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2022-294 which authorized
14 the Executive to advertise for bids for the Pavilion Construction Project, for the pavilion at the
15 Summit County Children Services Administration Building (the "Project"), located in the City of
16 Akron, in District 4, for a total not to exceed \$213,840.00; and

17
18 WHEREAS, after receiving three responses, the Executive selected Cavanaugh Building
19 Corporation was the lowest responsive and responsible bidder with a bid of \$224,900.00; and

21 WHEREAS, the Board of Control, at its meeting held on November 30, 2022, awarded
22 the aforementioned construction contract with Cavanaugh Building Corporation as the lowest
23 responsive and responsible bidder, for the pavilion project, in an amount not to exceed
24 \$224,900.00, subject to confirmation by this Council; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information
27 that the aforementioned construction contract with Cavanaugh Building Corporation is
28 necessary and in the best interest of the County of Summit;

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a construction contract with Cavanaugh Building
36 Corporation, as lowest responsive and responsible bidder, located in the City of Akron, in
37 Council District 4, in an amount not to exceed \$224,900.00, is hereby confirmed, and the
38 Executive is hereby authorized to execute said construction contract and any other necessary
39 related documents.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further reason to immediately
45 provide for necessary architectural design work for the Project.
