7 **A Resolution authorizing the Executive to advertise for bids for a jail bunk stabilization**
8 **project at the Jail, located in the City of Akron, in Council District 4, for an estimated total**
9 **cost not to exceed \$243,000.00, for the Executive’s Department of Administrative Services–**
10 **Physical Plants, and declaring an emergency.**

11
12 WHEREAS, the Executive wishes to advertise for bids for a jail bunk stabilization
13 project at the Jail (the “Project”), located in the City of Akron, in Council District 4, for an
14 estimated total cost not to exceed \$243,000.00, whereby the County will secure and stabilize all
15 bunk bed frames at the Jail that have been in use for over thirty (30) years increasing inmate
16 safety; and

18 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
19 requires this Council’s authorization for the Executive to advertise for bids for construction
20 contracts in excess of \$50,000.00; and

21
22 WHEREAS, a copy of the plans and specifications for the Project is on file with the
23 Clerk of Council; and

25 WHEREAS, the Capital Improvement Budget will pay for the costs of the Project; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary, and in the best interest of the County to authorize the Executive to advertise
29 for bids for the construction of the aforementioned Project, for an estimated total cost not to
30 exceed \$243,000.00;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The Executive is hereby authorized to advertise for bids for a jail bunk stabilization
38 project at the Jail (the “Project”), located in the City of Akron, in Council District 4, for an
39 estimated total cost not to exceed \$243,000.00.

41 SECTION 2

43 This Resolution is declared an emergency in the interest of the health, safety and welfare
44 of the residents of the County of Summit, and for the further reason to immediately advertise for
45 bids for the construction of the Project so that it may proceed in a timely manner.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


