12 amount of \$10,825,052.25 in order to meet obligations for the balance of the 2022 calendar year
13 as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated;

17 appropriations contained in Exhibit A are immediately needed for operations of the County and
18 are necessary and in the best interest of the County of Summit;

25 The Fiscal Officer is hereby authorized and directed to effect the appropriations set forth
26 in Exhibit A, attached to this Resolution and incorporated herein as if fully restated and
27 establishing fund(s) 28750, 23186, 20512, 27257, 23743, 28505 and 23247.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the residents of the County of Summit and for the further reason that the appropriations
33 contained in Exhibit A are immediately needed for operations of the County.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
38 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
39 be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
