7 **A Resolution confirming the award by the Board of Control of a purchase contract for**
8 **training services with Noble Supply and Logistics, LLC, as a Sole Source, for (3) Hazmat**
9 **IQ, (3) Biotech IQ and (3) Drug IQ trainings for the Summit County Special Operations**
10 **Response Team (SORT), Hazardous Materials Branch in an amount not to exceed**
11 **\$55,050.00, for the Executive's Department of Public Safety, Emergency Management**
12 **Agency and declaring an emergency.**

14 WHEREAS, the Executive seeks to enter into a purchase contract for training services
15 with Noble Supply and Logistics, LCC for trainings for the Summit County Special Operations
16 Response Team, Hazardous Materials Branch, for (3) Hazmat IQ, (3) Biotech IQ and (3) Drug
17 IQ trainings in an amount not to exceed \$55,050.00; and

19 WHEREAS, Noble Supply and Logistics, LLC, is a sole source provider for these
20 trainings because of their unique IQ 4-step system which is exclusively available from Noble
21 Supply and Logistics, LLC. This system will allow responders to quickly assess risks and make
22 proper decisions on how to best mitigate situations; and

24 WHEREAS, based on the above referenced factors, Noble Supply and Logistics, LLC, is
25 a Sole Source pursuant to Sections 177.01(h)(3)(A) and 177.07(a)(5) of the Codified Ordinances
26 of the County of Summit; and

28 WHEREAS, said trainings will be funded with the FY22 Hazardous Material Emergency
29 Preparedness (HMEP) Grant and Local Emergency Planning Committee (LEPC) funding; and

31 WHEREAS, the Board of Control, at its meeting held January 4, 2023, awarded a service
32 contract, with Noble Supply and Logistics, LLC, as a Sole Source, for Special Operation
33 Response Team Training, in an amount not to exceed \$55,050.00, subject to confirmation by this
34 Council; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that the aforementioned purchase contract with Noble Supply and Logistics, LLC, is necessary
38 and in the best interest of the County of Summit;

40 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The award by the Board of Control of a purchase contract with Noble Supply and
46 Logistics, LLC, for trainings for the Summit County Special Operations Response Team,
47 Hazardous Materials Branch in an amount not to exceed \$55,050.00, is hereby confirmed and the
48 Executive is hereby authorized to execute said purchase contract and any other necessary related
49 documents.
