7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **CATTS Construction, Inc. for the Christman Road Bridge Replacement Project, located in**
9 **the City of Green, in Council District 8, for a total amount not to exceed \$1,181,236.23, for**
10 **the Engineer, and declaring an emergency.**

11
12 WHEREAS, the Christman Road Bridge, located in the City of Green, in Council District
13 8, is currently closed due to its poor condition and requires replacement; and

14
15 WHEREAS, the Christman Road Bridge Replacement Project (the "Project") will replace
16 the structurally deficient, load posted, simple span prestressed concrete box beam structure over
17 Nimisila Reservoir with an entire new structure; and

18
19 WHEREAS, the City of Green is partnering with the County on this project and the new
20 bridge will include a 12 feet wide multi-purpose walkway to integrate with a planned trail in
21 Green; and

22
23 WHEREAS, the Engineer and Executive applied for and received 100% funding in Local
24 Bridge Replacement Program funds programmed through the County Engineer's Association of
25 Ohio. The City of Green and the County will split the local design costs; and

26
27 WHEREAS, this Council previously adopted Resolution No. 2021-149, authorizing the
28 Executive to execute a professional service contract with AECOM for design work on the
29 Project, for an amount not to exceed \$174,900.63; and

30
31 WHEREAS, the Council subsequently adopted Resolution No. 2022-86, authorizing the
32 Executive to advertise for bids for the Project, for an estimated total cost not to exceed
33 \$1,455,000.00; and

35 WHEREAS, after the Engineer sent out seven bid packets and received four bids, the
36 Executive selected CATTS Construction, Inc., as the lowest responsive and responsible bidder,
37 for the Project; and

39 WHEREAS, the Board of Control, at its meeting held January 25, 2023, awarded a
40 construction contract with CATTS Construction, Inc., as the lowest responsive and responsible
41 bidder for the Project, in an amount not to exceed \$1,181,236.23, subject to confirmation by this
42 Council; and

44 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
45 that the aforementioned construction contract with CATTS Construction, Inc. is necessary and in
46 the best interest of the County of Summit;

48 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
49 of Ohio, that:

6 The award by the Board of Control of a construction contract with CATTS Construction,
7 Inc. for the Christman Road Bridge Replacement Project (the "Project"), located in the City of
8 Green, in Council District 8, for a total amount not to exceed \$1,181,236.23, is hereby
9 confirmed, and the Executive is hereby authorized to execute said construction contract and any
10 other necessary related documents.

12 SECTION 2

14 This Resolution is hereby declared an emergency in the interest of the health, safety, and
15 welfare of the residents of the County of Summit, and for the further reason that it will allow the
16 County to proceed with the Project which will replace a structurally deficient bridge over
17 Nimisila Reservoir with an entire new structure.

21 Provided this Resolution receives the affirmative vote of eight members, it shall take
22 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
23 effect and be in force at the earliest time provided by law.

27 It is found and determined that all formal actions of this Council concerning and relating
28 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
29 deliberations of this Council and of any of its committees that resulted in such formal action,
