7 **A Resolution confirming the award by the Board of Control, subject to the approval of the**
8 **Information Technology Board, of a purchase contract with BeInCourt to provide annual**
9 **maintenance with on-site support, for the Criminal Justice Virtual Courtroom Project, for**
10 **the term of 7/1/23 through 6/30/24, for a total cost not to exceed \$345,142.32, with an option**
11 **to renew for an additional one-year term, for the Executive's Department of Public Safety,**
12 **and declaring an emergency.**

14 WHEREAS, this Council under Resolution No. 2020-358, previously approved a
15 professional service contract with ExhibitOne Corp., to provide hardware and software to support
16 county-wide virtual courtroom proceedings for criminal justice stakeholders throughout Summit
17 County; and

18
19 WHEREAS, BeInCourt, acting as a subcontractor for ExhibitOne Corp., has been
20 providing equipment and maintenance for the virtual courtroom since its inception; and

21
22 WHEREAS since the implementation of the Criminal Justice Virtual Courtroom Project,
23 various monitors now require replacement and are no longer covered under warranty; and

24
25 WHEREAS, BeInCourt has agreed to replace all of the monitors purchased under the
26 project, at no cost, as part of the execution of a one-year maintenance agreement, which includes
27 on-site support, for the term of 7/1/23 through 6/30/24, for a total cost not to exceed \$345,142.32,
28 with an option to renew for an additional one-year term; and

30 WHEREAS, the Information Technology Board, at its meeting to be held on February 16,
31 2023, will consider the aforementioned purchase contract with BeInCourt; and

33 WHEREAS, the Board of Control, at its meeting held February 8, 2023, awarded the
34 aforementioned purchase contract with BeInCourt, subject to the approval by the Information
35 Technology Board and confirmation by this Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that the aforementioned purchase contract with BeInCourt, subject to approval of the Information
39 Technology Board, is necessary and in the best interest of the County of Summit;

41 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 Subject to the approval of the Information Technology Board, the award by the Board of
47 Control of a purchase contract with BeInCourt to provide annual maintenance with on-site support,
48 for the criminal justice virtual courtroom project, for the term of 7/1/23 through 6/30/24, for a total
49 cost not to exceed \$345,142.32, with an option to renew for an additional one-year term is hereby
50 confirmed and the Executive is hereby authorized to execute said professional service contract and
51 any other necessary related documents.


