7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Kenworth of Richfield, at Sourcewell pricing, for two 2024 Kenworth T480 Tandem Axle**
9 **Cab & Chassis Dump/Plow Trucks, in a total amount not to exceed \$275,622.00, for the**
10 **Engineer, and declaring an emergency.**

12 WHEREAS, the Engineer budgets for the periodical purchase of vehicles, equipment and
13 components to replenish worn or past service life equipment and vehicles in order to continue to
14 provide general road maintenance and snow and ice control and in the 2023 general operating
15 budget previously adopted by this Council in Resolution No. 2022-342, funds were appropriated
16 for said purchases; and

18 WHEREAS, said purchase contract includes a five-year, 100,000 mile warranty on the
19 trucks; and

21 WHEREAS, Kenworth of Richfield is a contracted supplier under Sourcewell pricing for
22 equipment and vehicles and pursuant to Section 177.07(a)(11) of the Codified Ordinances of the
23 County of Summit is exempt from competitive bidding; and

25 WHEREAS, the Board of Control, at its meeting held on February 15, 2023, awarded a
26 purchase contract to Kenworth of Richfield, at Sourcewell pricing, for two 2024 Kenworth T480
27 Tandem Axle Cab & Chassis Dump/Plow Trucks, in a total amount not to exceed \$275,622.00,
28 subject to confirmation by this Council; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that the aforementioned purchase contract with Kenworth of Richfield is necessary and in the
32 best interest of the County of Summit;

34 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The award by the Board of Control of a purchase contract with Kenworth of Richfield, at
40 Sourcewell pricing, for two 2024 Kenworth T480 Tandem Axle Cab & Chassis Dump/Plow
41 Trucks, in a total amount not to exceed \$275,622.00, is hereby confirmed and the Executive is
42 hereby authorized to execute said purchase contract and any other necessary related documents.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further reason that the
48 aforementioned purchase contract with Kenworth of Richfield is immediately necessary to
49 provide needed equipment for use by the Engineer.
