7 **A Resolution authorizing the Executive to advertise for bids for drop-in childcare services**  
8 **at the OhioMeansJobs Summit County Facility, located in the City of Akron, in Council**  
9 **District 2, for an estimated cost not to exceed \$95,000.00, for the Executive's Department of**  
10 **Job and Family Services, and declaring an emergency.**

11  
12 WHEREAS, this Council previously adopted Resolution No. 2019-334, which confirmed  
13 the award by the Board of Control of a contract with the Akron Area YMCA to provide drop-in  
14 childcare services at the OhioMeansJobs Summit County Facility, from 10/1/19 to 9/30/20, with  
15 two options to renew, each for an additional one-year term; and

16  
17 WHEREAS, this Council subsequently adopted Resolution Nos. 2021-260 and 2022-237,  
18 approving the first and second renewals of the aforementioned contract respectively, with the  
19 second and final renewal expiring on 9/30/23; and

20  
21 WHEREAS, this Executive wishes to advertise for bids for drop-in childcare services at  
22 the OhioMeansJobs Summit County Facility, located in the City of Akron, in Council District 2,  
23 for an estimated cost not to exceed \$95,000.00, with the contract period, once awarded, being  
24 from 10/1/23 to 9/30/24, with four options to renew for an additional one-year term; and

26 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
27 requires this Council's authorization to advertise for bids for contracts in excess of \$50,000.00;  
28 and

30 WHEREAS, a copy of the bid specifications is on file with the Clerk of Council; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
34 advertise for bids for drop-in childcare services at the OhioMeansJobs Summit County Facility,  
35 for an estimated cost not to exceed \$95,000.00;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that;

40 SECTION 1

42 The Executive is authorized to advertise for bids for drop-in childcare services at the  
43 OhioMeansJobs Summit County Facility, located in the City of Akron, in Council District 2, for  
44 an estimated cost not to exceed \$95,000.00, with four annual renewal options.

46 SECTION 2

48 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
49 of the residents of the County of Summit, and for the further reason to immediately advertise for  
50 bids for the aforementioned drop-in childcare services so that the necessary services may be  
51 provided in a timely manner.

16 121.22 of the Ohio Revised Code.


