7 **A Resolution confirming the award by the Board of Control of a Temporary Assistance to**  
8 **Needy Families agreement with Tri-County Jobs for Ohio's Graduates (JOG) for 2023**  
9 **Summer Youth Employment Program outreach and eligibility services, for the period of**  
10 **4/1/23 through 8/31/23, in an amount not to exceed \$100,000.00, for the Executive's**  
11 **Department of Job and Family Services, and declaring an emergency.**

12  
13 WHEREAS, the Executive's Department of Job and Family Services ("DJFS") wishes to  
14 enter into a Temporary Assistance to Needy Families ("TANF") agreement with Tri-County Jobs  
15 for Ohio's Graduates ("JOG") for 2023 Summer Youth Employment Program outreach and  
16 eligibility services; and

18 WHEREAS, under the agreement, JOG will be responsible for employer recruitment,  
19 youth job matching, keeping job slots filled, site monitoring, picking up time sheets to be sent to  
20 a payroll vendor, general supervision and troubleshooting day-to-day issues; and

21  
22 WHEREAS, JOG will also be responsible for adhering to reporting requirements,  
23 providing oversight of supervisory staff, work readiness skills training and general guidance to  
24 youth who are assigned to various work experience sites throughout Summit County; and

25  
26 WHEREAS, the Board of Control, at its meeting held March 1, 2023, awarded a TANF  
27 agreement with JOG, which is exempt from competitive bidding due to the provider's subgrantee  
28 status, for 2023 Summer Youth Employment Program outreach and eligibility services, for the  
29 period of 4/1/23 through 8/31/23, in an amount not to exceed \$100,000.00, subject to  
30 confirmation by this Council; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that a TANF agreement with JOG is necessary and in the best interest of the County of Summit;

35 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

40 The award of a Temporary Assistance to Needy Families ("TANF") agreement with Tri-  
41 County Jobs for Ohio's Graduates for 2022 Summer Youth Employment Program outreach and  
42 eligibility services for the period of 4/1/23 through 8/31/23, in an amount not to exceed  
43 \$100,000.00, is hereby confirmed and the Executive is hereby authorized to execute said TANF  
44 agreement and any other necessary related documents.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and  
49 welfare of the residents of Summit County, and for the further reason to immediately approve the  
50 necessary TANF agreement to provide summer youth employment outreach and eligibility  
51 services.


