7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Zix Corporation, as a Best Practical Source, for Migration of Office365 service over to**
9 **Zix/AppRiver/OpenText as a Cloud Solution Provider, for a one-year term, from 5/1/23**
10 **through 4/30/24, in an amount not to exceed \$247,656.00, for the Office of Information**
11 **Technology, and declaring an emergency.**

13 WHEREAS, the migration of Office365 service over to Zix/AppRiver/OpenText as a
14 Cloud Solution Provider will provide additional support and service management operations for
15 the County; and

16
17 WHEREAS, Zix Corporation (“Zix”) is a Best Practical Source pursuant to Sections
18 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit because
19 the functional advantage of moving the O365 contract over to Zix which will provide a single
20 vendor to contact regarding any issues related to our email service and they already handle the
21 County’s spam filtering and email encryption; and

23 WHEREAS, the Board of Control, at its meeting held March 15, 2023, awarded a
24 purchase contract with Zix, as a Best Practical Source, approved by the Information Technology
25 Board at its meeting held on March 9, 2023, for Migration of Office365 service over to
26 Zix/AppRiver/OpenText as a Cloud Solution Provider, for a one-year term, from 5/1/23 through
27 4/30/24, in an amount not to exceed \$247,656.00, subject to confirmation by this Council; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 the aforementioned purchase contract with Zix is necessary and in the best interest of the County
31 of Summit;

33 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

41 for a one-year term, from 5/1/23 through 4/30/24, in an amount not to exceed \$247,656.00, is
42 hereby confirmed and the Executive is hereby authorized to execute said purchase contract and
43 any other necessary related documents.
