7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Bad Day Training & Consulting to provide training for Ohio Region 5 Collapsed Search**
9 **and Rescue (CSAR) Rescue Tech Series Training for Portage County, in an amount not to**
10 **exceed \$97,490.00, for the Executive's Department of Public Safety, Emergency**
11 **Management Agency, and declaring an emergency.**

13 WHEREAS, the Executive's Department of Public Safety, Emergency Management
14 Agency wishes to execute a purchase contract to provide training for Ohio Region 5 CSAR
15 Rescue Tech Series Training for Portage County; and

16
17 WHEREAS, the proposed training will be for rescue rope operations, confined space
18 operations, swift-water operations, vehicle/heavy machinery extrication, trench rescue operations
19 and structural collapse operations training; and

20
21 WHEREAS, the Council previously adopted resolution No. 2022-322, which authorized
22 the Executive to advertise for bids for said training, for an estimated amount not to exceed
23 \$106,296.00; and

25 WHEREAS, the training will be fully-grant funded; and

27 WHEREAS, after advertising for bids, the Executive has selected Bad Day Training &
28 Consulting, as the lowest responsive and responsible bidder; and

30 WHEREAS, the Board of Control, at its meeting held March 29, 2023, awarded a
31 purchase contract with Bad Day Training & Consulting to provide training for Ohio Region 5
32 CSAR Rescue Tech Series Training for Portage County, in an amount not to exceed \$97,490.00,
33 subject to confirmation by this Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that the aforementioned purchase contract with Bad Day Training & Consulting is necessary and
37 in the best interest of the County of Summit;

39 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

44 The award by the Board of Control of a purchase contract with Bad Day Training &

47 is hereby authorized to execute said purchase contract and any other necessary related
