7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Karvo Companies, Inc. for the 2023 Summit County 441 Asphalt Concrete (448)**
9 **Resurfacing Program-South, in an amount not to exceed \$1,190,513.80, for the Engineer,**
10 **and declaring an emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2022-370, which authorized
13 the Executive to advertise, as needed, for bridge engineering and construction projects, and
14 pavement maintenance projects, for the Engineer’s 2023 Capital Improvements Program, and
15 federal and state funded projects, for an estimated total cost not to exceed \$13,962,800.00; and

16
17 WHEREAS, said projects were approved as part of the Capital Improvements Program
18 for 2023-2028 by Resolution No. 2023-025; and

19
20 WHEREAS, following the receipt and review of six bids, the Executive has proposed
21 entering into a construction contract with Karvo Companies, Inc. for the 2023 Summit County
22 441 Asphalt Concrete (448) Resurfacing Program-South in an amount not to exceed
23 \$1,190,513.80; and

25 WHEREAS, the work to be performed by Karvo Companies, Inc. will consist of
26 resurfacing various County and Copley Township roads, including milling, pavement repairs,
27 chip seal prior to resurfacing, an asphalt concrete surface course and new pavement markings;

30 WHEREAS, the contract total in an amount not to exceed \$1,190,513.80 will be broken
31 down by political subdivision as follows with each subdivision responsible for directly paying
32 the contractor:

34 County: \$752,946.30
35 County Alternate 1: \$163,516.00
36 Copley Township: \$274,051.50; and

39 WHEREAS, the Board of Control, at its meeting held on March 22, 2023, awarded a
40 construction contract with Karvo Companies, Inc., as the lowest responsive and responsible
41 bidder, for the 2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-South, in
42 an amount not to exceed \$1,190,513.80, subject to confirmation by this Council; and

44 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
45 that the aforementioned construction contract with Karvo Companies, Inc. for the 2023 Summit
46 County 441 Asphalt Concrete (448) Resurfacing Program-South is necessary and in the best
47 interest of the County of Summit;

49 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

6 The award by the Board of Control of a construction contract with Karvo Companies,
7 Inc. for the 2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-South, in an
8 amount not to exceed \$1,190,513.80, is hereby confirmed and the Executive is hereby authorized
9 to execute said construction contract and any other necessary related documents.

11 SECTION 2

13 This Resolution is hereby declared an emergency in the interest of the health, safety and
14 welfare of the residents of the County of Summit, and for the further purpose to immediately
15 provide necessary pavement repairs to various County and Copley Township roads in 2023.

19 Provided this Resolution receives the affirmative vote of eight members, it shall take
20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
21 effect and be in force at the earliest time provided by law.

25 It is found and determined that all formal actions of this Council concerning and relating
26 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
27 deliberations of this Council and of any of its committees that resulted in such formal action,
28 were in meetings open to the public, in compliance with all legal requirements, including Section
29 121.22 of the Ohio Revised Code.
