7 **A Resolution confirming the award by the Board of Control of a purchase order for**
8 **ProTech to provide night vision equipment for the Tuscarawas County Sheriff's Office**
9 **SWAT Team, Ohio Region 5, in an amount not to exceed \$39,624.00, for the Executive's**
10 **Department of Public Safety, Emergency Management Agency, and declaring an**
11 **emergency.**

13 WHEREAS, the Executive's Department of Public Safety, Emergency Management
14 Agency wishes to obtain a purchase order from ProTech to provide night vision equipment for
15 the Tuscarawas County Sheriff's Office SWAT Team; and

16
17 WHEREAS, the equipment will be used for the purposes of counter-terrorism and search
18 and rescue operations, and to assist the SWAT Team in responding to emerging threats; and

19
20 WHEREAS, pursuant to Section 177.13 of the Codified Ordinances of the County of
21 Summit, Council approval for this purchase is necessary due to the aggregate of \$50,000.00
22 being spent on multiple purchase from this vendor within the current calendar year; and

24 WHEREAS, ProTech was the lowest of three quotes obtained for this project, and fully
25 met the equipment specifications; and

26
27 WHEREAS, the equipment will be fully-grant funded; and

29 WHEREAS, the Board of Control, at its meeting held April 5, 2023, approved ProTech,
30 as the lowest responsive and responsible bidder, for a purchase order to provide night vision
31 equipment for the Tuscarawas County Sheriff's Office SWAT Team, Ohio Region 5, in an
32 amount not to exceed \$39,624.00, subject to confirmation by this Council; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that the aforementioned purchase order for ProTech is necessary and in the best interest of the
36 County of Summit;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

43 The approval by the Board of Control of a purchase order for ProTech to provide night
44 vision equipment for the Tuscarawas County Sheriff's Office SWAT Team, Ohio Region 5, in an
45 amount not to exceed \$39,624.00, is hereby confirmed and the Executive is hereby authorized to
46 execute said purchase order and any other necessary related documents.
