**A Resolution approving and authorizing the Executive to execute and submit the Community Development Block Grant and HOME Investment Partnership Program 2023 Action Plan to the U.S. Department of Housing and Urban Development for program year 2023 and authorizing the Executive to execute the 2023 Community Development Block Grant and HOME Investment Partnership Program contracts, for the Executive’s Department of Community and Economic Development, and declaring an emergency.**

WHEREAS, as a prerequisite for receiving Community Development Block Grant (“CDBG”) and Home Investment Partnership Program (“HOME”) funding for program year 2023, the County is required to submit a 2023 Action Plan to the U.S. Department of Housing and Urban Development (“HUD”) by August 28, 2023; and

WHEREAS, the County of Summit anticipates receiving \$974,810.00 in CDBG funding and \$442,718.00 in HOME funding for the 2023 program year; and

WHEREAS, the County of Summit CDBG Review Committee has reviewed and approved the 2023 CDBG projects and recommended project funding for the activities set forth in Exhibit A, which is attached hereto and incorporated herein as if fully restated; and

WHEREAS, the Department of Community and Economic Development has prepared the 2023 Action Plan for CDBG and HOME programs, which is due to HUD by August 28, 2023; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to approve and authorize the Executive to execute and submit the 2023 Action Plan for the CDBG and HOME activities to HUD;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Executive is hereby authorized to execute and submit the 2023 Action Plan to the U.S. Department of Housing and Urban Development (“HUD”) for the 2023 program year for Community Development Block Grant (“CDBG”) and Home Investment Partnership Program (“HOME”) federal funding awards; said 2023 Action Plan activities shall include the activities as set forth in Exhibit A, which is attached hereto and incorporated herein as if fully restated.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the further purpose to immediately authorize the Executive to execute and submit the CDBG and HOME 2023 Action Plan to HUD by the August 28, 2023, deadline and to immediately facilitate CDBG and HOME funding for the program year 2023.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Ohio Revised Code.
