7 **A Resolution authorizing the Executive to advertise for bids for a five-year full**
8 **maintenance service agreement for elevator maintenance at six County buildings, located**
9 **in the Cities of Cuyahoga Falls and Akron, in Council Districts 2 and 4, for an estimated**
10 **total cost not to exceed \$160,000.00, for the Executive’s Department of Administrative**
11 **Services-Physical Plants Division, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council’s authorization for the Executive to advertise for bids; and

15

16 WHEREAS, the Executive wishes to advertise for bids for a five-year full maintenance
17 service agreement for twelve elevators at six County maintained buildings (2525 State Road,
18 Courthouse, Jail, Ohio Building, County Parking Deck and Summit County Board of Elections),
19 located the Cities of Cuyahoga Falls and Akron, in Council Districts 2 and 4, for an estimated
20 cost not to exceed \$160,000.00; and

22 WHEREAS, the current elevator service maintenance agreements expire on June 30,
23 2023; and

25 WHEREAS, a copy of the bid specifications is on file with the Clerk of Council; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the Executive to
29 advertise for bids for a five-year full maintenance service agreement for twelve elevators at six
30 County maintained buildings;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

37 The Executive is hereby authorized to advertise for bids for a five-year full maintenance
38 service agreement for twelve elevators at six County maintained buildings, located in the Cities
39 of Cuyahoga Falls and Akron, in Council Districts 2 and 4, for an estimated total cost not to
40 exceed \$160,000.00

42 SECTION 2

44 This Resolution is declared an emergency in the interest of the health, safety, and welfare
45 of the residents of the County of Summit, and for the further reason that it authorizes the
46 Executive to immediately advertise for bids for the aforementioned elevator maintenance service
47 agreement, in order to ensure that an agreement is in place prior to the current agreements’
48 expiration date.


