7 **A Resolution confirming the award by the Board of Control of a construction contract**
8 **with Johnson Controls Fire Protection LP, at State Term Pricing, for upgrades to the Fire**
9 **Alarm System at the Jail, in an amount not to exceed \$210,520.33, for the Executive’s**
10 **Department of Administrative Services-Physical Plants, and declaring an emergency.**

11

12 WHEREAS, this Council previously adopted Resolution No. 2022-052, which authorized
13 the Executive to enter into agreements with various contractors for HVAC and Plumbing projects
14 at the Jail in an amount not to exceed \$11,132,343.00; and

15

16 WHEREAS, this Council subsequently adopted Resolution No. 2022-378, which
17 authorized the Executive to advertise for bids for the shower renovation project for an estimated
18 costs not to exceed \$1,300,000.00; and

19

20 WHEREAS, while the HVAC and Plumbing projects are ongoing at the Jail, it is
21 necessary to upgrade a portion of the Jail’s Fire Alarm system to make the new appliances and
22 fixtures compatible with the Fire Alarm System; and

24 WHEREAS, the Executive wishes to enter into a construction contract with Johnson
25 Controls Fire Protection LP, at State Term Pricing, for the aforementioned upgrades at the Jail;
26 and

28 WHEREAS, the Board of Control, at its meeting held on April 19, 2023, awarded a
29 construction contract with Johnson Controls Fire Protection LP, at State Term Pricing, for
30 upgrades to the Fire Alarm System at the Jail, in an amount not to exceed \$210,520.33, subject
31 to confirmation by this Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that the aforementioned construction contract with Johnson Controls Fire Protection LP is
35 necessary and in the best interest of the County of Summit;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that;

42 The award by the Board of Control of a construction contract with Johnson Controls Fire
43 Protection LP, at State Term Pricing, for upgrades to the Fire Alarm System at the Jail, in an
44 amount not to exceed \$210,520.33, is hereby confirmed and the Executive is hereby authorized
45 to execute said construction contract and any other necessary related documents.

49 This Resolution is declared an emergency in the interest of the health, safety, and welfare
50 of the residents of the County of Summit, and for the further reason that it immediately
51 authorizes a necessary construction contract for upgrades to the Jail Fire Alarm System to
