7 **A Resolution confirming the award by the Board of Control of a construction contract with**  
8 **Karvo Companies, Inc., funded in part by a grant from the Akron Metropolitan Area**  
9 **Transportation Study (AMATS) Resurfacing Program, for the Swartz Road Resurfacing**  
10 **Project, located in Coventry Township, in Council District 8, in an amount not to exceed**  
11 **\$1,028,025.04, for the Engineer, and declaring an emergency.**

12  
13 WHEREAS, this Council previously adopted Resolution No. 2022-370, which authorized  
14 the Executive to advertise for bridge engineering and construction projects, and pavement  
15 maintenance projects, for the Engineer’s 2023 Capital Improvements Program, for an estimated  
16 cost not to exceed \$13,962,800.00; and

17  
18 WHEREAS, the Executive received \$500,000.00 in grant funding from the Akron  
19 Metropolitan Area Transportation Study (AMATS) Resurfacing Program for the resurfacing and  
20 shoulder widening of Swartz Road beginning at S. Main Street and ending at the City of Akron  
21 corporation limits near Penguin Drive; and

22  
23 WHEREAS, following the receipt and review of three bids, the Executive proposes  
24 entering into a construction contract with Karvo Companies, Inc., as the lowest responsive and  
25 responsible bidder, for the Swartz Road Resurfacing Project (the “Project”), in an amount not to  
26 exceed \$1,028,025.04; and

27  
28 WHEREAS, the Board of Control, at its meeting held May 3, 2023, awarded a  
29 construction contract with Karvo Companies, Inc. for the for Project, located in Coventry  
30 Township, in Council District 8, in an amount not to exceed \$1,028,025.04, subject to  
31 confirmation by this Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
34 that the aforementioned construction contract with Karvo Companies, Inc. is necessary and in the  
35 best interest of the County of Summit;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that;

42 The award by the Board of Control of a construction contract with Karvo Companies,  
43 Inc., for the Swartz Road Resurfacing Project (the “Project”), located in Coventry Township, in  
44 Council District 8, in an amount not to exceed \$1,028,025.04, is hereby confirmed and the  
45 Executive is hereby authorized to execute said construction contract and any other necessary  
46 related documents.

8 provide a necessary construction contract for the Project.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take  
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating  
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
20 deliberations of this Council and of any of its committees that resulted in such formal action,

22 121.22 of the Ohio Revised Code.
