7 **A Resolution confirming the award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with United Way of Summit and Medina, in an amount not to**
9 **exceed \$325,000.00, (for a cumulative increase of 162.5%), for a total amount not to exceed**
10 **\$525,000.00, for the Executive's Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2022-284, which authorized
14 the Executive to execute a contract with United Way of Summit and Medina which provides
15 homeless prevention services in an amount not to exceed \$200,000.00; and

16

17 WHEREAS, the services contracted for assist Summit County residents that are
18 homeless, or at risk of becoming homeless in less than 14 days, and focus on preventing eminent
19 homelessness and quickly re-housing through financial assistance and stabilization support, and
20 the financial assistance includes short term rental assistance, security deposits, utility payments
21 and moving expense assistance, and the stabilization services include case management, housing
22 search and placement, legal services and credit repair and this change order is necessary to meet
23 the increasing need for services provided under this contract; and

25 WHEREAS, the Board of Control, at its May 10, 2023 meeting, awarded the above-
26 referenced change order in an amount not to exceed \$325,000.00, (for a cumulative increase of
27 162.5%), for a total amount not to exceed \$525,000.00; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that Change Order No. 1 to the aforementioned contract with United Way of Summit and Medina
31 is necessary and in the best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The award by the Board of Control of Change Order No. 1 to a contract with United
39 Way of Summit and Medina to meet the increasing need for homeless prevention services in an
40 amount not to exceed \$325,000.00, (for a cumulative increase of 162.5%), for a total amount not
41 to exceed \$525,000.00, is hereby confirmed and the Executive is hereby authorized to execute
42 said change order and any other necessary related documents.

46 This Resolution is declared an emergency in the interest of the health, safety and welfare
47 of the residents of the County of Summit and for the further reason to immediately confirm the
48 award of a necessary change order to the contract in order to meet the increasing needs for these
49 services in the community.
