7 **A Resolution authorizing the Executive to advertise for bids for armored car services, for a**
8 **one-year period, with four options to renew for an additional one-year period, for an**
9 **estimated cost not to exceed \$65,000.00 per year, for the Executive’s Department of**
10 **Finance and Budget - Purchasing, and declaring an emergency.**

12 WHEREAS, armored car services are required to provide pickup and delivery of various
13 Summit County Building cashier’s office receipts for safe and secure same day deposits; and

14

15 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
16 requires this Council’s authorization for the Executive to advertise for bids; and

18 WHEREAS, the Executive wishes to advertise for bids for armored car services, for a
19 one-year period, with four options to renew for a one-year period, for an estimated cost not to
20 exceed \$65,000.00 per year; and

22 WHEREAS, a copy of the specifications are on file in the office of the Clerk of Council;

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that is necessary and in the best interest of the County of Summit to authorize the Executive to
27 advertise for bids for the aforementioned project;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The Executive is authorized to advertise for bids for armored car services, for a one-year
35 period, with four options to renew for a one-year period, for an estimated cost not to exceed
36 \$65,000.00 per year.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare
41 of the residents of the County of Summit, and for the further reason that it authorizes the
42 Executive to immediately advertise for bids for necessary armored car services for the County.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
