7 **A Resolution confirming the award by the Board of Control of professional service**
8 **contracts with various providers of delinquent care and custody grant services, for the**
9 **period 7/1/23 through 6/30/24, in a total amount not to exceed \$1,153,084.00, for the Court**
10 **of Common Pleas-Juvenile Division, and declaring an emergency.**

12 WHEREAS, the Court of Common Pleas-Juvenile Division has received a State Fiscal
13 Year 2024 Ohio Department of Youth Services Delinquent Care & Custody (“DC&C”) grant, in
14 the amount of \$1,153,084.00, for the period 7/1/23 through 6/30/24; and

16 WHEREAS, the DC&C grant allows local courts to develop or purchase a range of
17 community based services to meet the needs of juvenile offenders or youth at risk of offending;
18 and

20 WHEREAS, the Board of Control, at its meeting held June 7, 2023, awarded professional
21 service contracts with various providers, a complete listing of including the contract amounts is
22 attached to this Resolution as Exhibit A and incorporated herein as if fully restated, for
23 delinquent care and custody grant services, which as grant contracts and pursuant to Section
24 177.07(a)(12) of the Codified Ordinances of the County of Summit are exempt from competitive
25 bidding, for the period 7/1/23 through 6/30/24, in a total amount not to exceed \$1,153,084.00,
26 subject to confirmation by this Council; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that the aforementioned professional service contracts with various providers are necessary and
30 in the best interest of the County of Summit;

32 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of professional service contracts with various
38 providers for delinquent care and custody grant services, as set forth in Exhibit A, which is
39 attached to this Resolution and incorporated herein as if fully restated, for the period 7/1/23
40 through 6/30/24, in a total amount not to exceed \$1,153,084.00, is hereby confirmed and the
41 Executive is hereby authorized to execute the aforementioned professional service contracts and
42 any necessary related documents.

47 welfare of the residents of the County of Summit, and for the further reason to immediately
48 provide for delinquent care and custody grant services effective 7/1/23.
