7 **An Ordinance amending Section 119A.03 of the Codified Ordinances of the County of**
8 **Summit entitled “Payment Procedures,” to remove the former Banner fund, org and**
9 **account number, and declaring an emergency.**

10

11 WHEREAS, Chapter 119A.03 of the Codified Ordinances of the County of Summit, sets
12 forth the rules and regulations concerning the payment of sewer backup claims; and

13

14 WHEREAS, section 119A.03(g) contains a fund, org and account number that was
15 utilized in the Banner accounting system; and

16

17 WHEREAS, Banner has been replaced by the Tyler Enterprise system and the old
18 numbering system has been replaced and it is not necessary to have an actual account number in
19 the Ordinance; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to amend Section 119A.03 of
23 Codified Ordinances for the reasons set forth above;

25 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
26 of Ohio, that:

28 SECTION 1

30 Section 119A.03 of the Codified Ordinances of the County of Summit, entitled “Payment
31 Procedures,” is hereby amended as set forth on Exhibit A, attached hereto and incorporated
32 herein by reference.

34 SECTION 2

36 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
37 welfare of the residents of the County of Summit and for the further purpose of immediately
38 amending Section 119A.03 in order to allow the Department of Sanitary Sewer Services to
39 timely reimburse residents impacted by a sewer backup.

43 Provided this Ordinance received the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
