Tultz) 3 SPONSOR Executive Shapiro and Council as a Whole 4 5 DATE June 26, 2023 COMMITTEE <u>Human Services</u> 6 7 A Resolution authorizing the Executive to execute a subgrant agreement with the Ohio 8 Department of Job and Family Services for grants received by the Prosecutor's Child 9 Support Enforcement Agency during State Fiscal Years 2024 and 2025, for the period 10 7/1/23 through 6/30/25, for the Prosecutor's Child Support Enforcement Agency, and 11 declaring an emergency. 12 13 WHEREAS, Section 5101.21 of the Ohio Revised Code provides that the Ohio 14 Department of Job and Family Services ("ODJFS") may only make grants to counties through 15 subgrant agreements described in that section; and 16 17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, ODJFS 18 developed a standard subgrant agreement to be executed by the commissioners, or in the case of 19 a charter county, the executive, of each county prior to receiving ODJFS grant funds; and 20 21 WHEREAS, the Prosecutor's Child Support Enforcement Agency ("CSEA") has 22 received from the State the standard subgrant agreement for State Fiscal Years ("SFY") 2024 and 23 2025, for the period 7/1/23 through 6/30/25, that sets forth the rights and responsibilities of 24 ODJFS and CSEA in relation to any subgrant that is awarded for SFY 2024 and 2025; and 25 26 WHEREAS, this Council finds and determines, after reviewing all pertinent information, 27 that is necessary and in the best interest of the County of Summit to authorize the Executive to 28 execute said subgrant agreement for SFY 2024 and 2025; 29 30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State 31 of Ohio, that; 32 33 **SECTION 1** 34 35 The Executive is authorized to execute a subgrant agreement with the Ohio Department 36 of Job and Family Services ("ODJFS") and the Summit County Child Support Enforcement 37 Agency ("CSEA") for subgrants received by CSEA for State Fiscal Years 2024 and 2025, for the 38 period 7/1/23 through 6/30/25. The Executive is hereby authorized to execute said subgrant 39 agreement, a copy of which is attached hereto as Exhibit A and incorporated fully herein, with 40 such modifications and revisions as shall be in furtherance of the provisions of said subgrant 41 agreement and not substantially adverse to the County, all of which shall be conclusively 42 evidenced by the execution thereof by the Executive. 43 44 **SECTION 2** 45 46 This Resolution is declared an emergency in the interest of the health, safety, and welfare 47 of the residents of the County of Summit, and for the further reason that it is necessary to 48 immediately authorize the Executive to execute said subgrant agreement so that CSEA is eligible 49 to be awarded subgrant funds from ODJFS for SFY 2024 and 2025, effective 7/1/23. 50 51
