7 **A Resolution certifying Surface Water Management District charges to the Fiscal Officer,**
8 **for the Engineer, and declaring an emergency.**

10 WHEREAS, the billing records at the Engineer's Office show surface water utility
11 accounts which represent charges due; and

12

13 WHEREAS, Section 942.15 of the Codified Ordinances of the County of Summit
14 provides that these charges are to be placed on the property tax duplicate for collection; and

15

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that it is necessary and in the best interest of the County of Summit to certify the aforementioned
18 charges to the Fiscal Officer;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that;

23 SECTION 1

25 The surface water utility accounts listed in Exhibit A, attached hereto and incorporated
26 herein as if fully restated, are hereby certified to the Fiscal Officer to be placed on the tax list and
27 duplicate on their respective Parcels for collection as other taxes are collected.

29 SECTION 2

31 The Clerk of Council shall deliver a copy of this Resolution to the Fiscal Officer who
32 shall record the surface water utility charges for collection pursuant to the Codified Ordinances
33 of the County of Summit.

35 SECTION 3

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the residents of the County of Summit, and for the further reason to immediately
39 ensure the certification of charges to the Fiscal Officer.

41 SECTION 4

43 Provided this resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
