7 **A Resolution authorizing the Executive to advertise for bids for the Summit County**
8 **Sheriff’s Storage Building Electric Service Project, located in the City of Tallmadge, in**
9 **Council District 6, for an estimated total cost not to exceed \$105,000.00, for the Executive’s**
10 **Department of Administrative Services-Physical Plants Division, and declaring an**
11 **emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council’s authorization for the Executive to advertise for bids; and

15

16 WHEREAS, the Executive wishes to advertise for bids for the completion of the Summit
17 County Sheriff’s Storage Building Electric Service Project (the “Project”), located at 163 E.
18 Howe Avenue, located in the City of Tallmadge, in Council District 6, for an estimated cost not
19 to exceed \$105,000.00; and

21 WHEREAS, the building located at 163 E. Howe Avenue in Tallmadge was previously
22 used as the Summit DD bus maintenance garage located east of the Summit DD school building;
23 and

25 WHEREAS, the building’s existing electric service is provided by the Summit DD
26 school, which the City of Tallmadge plans to demolish; and

28 WHEREAS, a new electrical connection must be established from the street in order for
29 the Sheriff’s Storage Building located at 163 E. Howe Avenue to continue to operate;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that;

36 The Executive is hereby authorized to advertise for bids for the Summit County Sheriff’s
37 Storage Building Electric Service Project (the “Project”), located in the City of Tallmadge, in
38 Council District 6, for an estimated total cost not to exceed \$105,000.00.

42 This Resolution is declared an emergency in the interest of the health, safety, and welfare
43 of the residents of the County of Summit, and for the further reason that it authorizes the
44 Executive to immediately advertise for bids for the Project.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
