7 **A Resolution authorizing the Executive to execute an intergovernmental agreement with**
8 **the Summit County Combined General Health District dba Summit County Public Health,**
9 **to increase utilization of Healthchek Early, Periodic, Screening, Diagnostic and Testing**
10 **services for young children, for a one-year term, from 10/1/23 to 9/30/24, in an amount not**
11 **to exceed \$120,000.00, for the Executive’s Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Executive wishes to enter into an intergovernmental agreement with the
15 Summit County Combined General Health District dba Summit County Public Health, to
16 increase utilization of Healthchek Early, Periodic, Screening, Diagnostic and Testing services for
17 young children, for a one-year term, from 10/1/23 to 9/30/24, in an amount not to exceed
18 \$120,000.00; and

20 WHEREAS, services provided by Summit County Public Health will include outreach to
21 educate families about the importance of timely screenings and Healthchek services, such as,
22 Help Me Grow, Infant Mortality prevention, and WIC services, to help families understand care,
23 safety and developmental needs of young children; and

25 WHEREAS, services provided will also include outreach and education to connect high
26 risk pregnant women to community resources needed for healthy pregnancies and promote
27 healthy maternal nutrition habits, along with smoking cessation, and will include follow-up
28 support; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that the aforementioned intergovernmental agreement with the Summit County Public Health is
32 necessary and in the best interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

39 The Executive is hereby authorized to execute an intergovernmental agreement and any
40 other necessary related documents with the Summit County Combined General Health District
41 dba Summit County Public Health to increase utilization of Healthchek Early, Periodic,
42 Screening, Diagnostic and Testing services for young children, for a one-year term, from 10/1/23
43 to 9/30/24, in an amount not to exceed \$120,000.00.

47 This Resolution is hereby declared an emergency in the interest of the health, safety, and
48 welfare of the residents of the County of Summit and for the further reason of immediately
49 providing necessary services for you children and high-risk pregnant women through the
50 Executive’s Department of Job and Family Services effective 10/1/23.
