7 **A Resolution authorizing the Executive to advertise for bids for the Summit County**
8 **Parking Deck Improvement Project, located in the City of Akron, in Council District 4, for**
9 **an estimated total cost not to exceed \$2,068,359.26, for the Executive’s Department of**
10 **Administrative Services–Physical Plants, and declaring an emergency.**

11

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council’s authorization for the Executive to advertise for bids; and

14

15 WHEREAS, the original Parking Deck was built in 1977 and 2 upper decks were added
16 in 2002. This will be the first major renovation since then; and

17

18 WHEREAS, the Executive’s Department of Administrative Services–Physical Plants
19 wishes to undertake the Summit County Parking Deck Improvement Project (the “Project”) as
20 the Parking Deck requires multiple structural repairs along with an overall cleaning and painting
21 of all the stairwells, restriping of parking spaces, sealcoating of the upper deck level, and
22 cleaning of the exterior facade; and

24 WHEREAS, this project will allow the County to help provide a safer, cleaner parking
25 deck well into the future; and

27 WHEREAS, the Executive wishes to advertise for bids for the Project at the Summit
28 County Parking Deck, for an estimated total cost not to exceed \$2,068,359.26; and

30 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council’s Office;
31 and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that is necessary and in the best interest of the County of Summit to authorize the Executive to
35 advertise for bids for the Project, for an estimated total cost not to exceed \$2,068,359.26;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that;

42 The Executive is hereby authorized to advertise for bids for the Summit County Parking
43 Deck Improvement Project, located in the City of Akron, in Council District 4, for an estimated
44 total cost not to exceed \$2,068,359.26

48 This Resolution is declared an emergency in the interest of the health, safety, and welfare
49 of the residents of the County of Summit, and for the further reason that it authorizes the
50 Executive to immediately advertisement for bids for necessary improvements to the Summit
51 County Parking Deck.
