1 RESOLUTION NO. 2023-260 2 3 SPONSOR Executive Shapiro 4 DATE August 21, 2023 5 COMMITTEE Finance 6 7 A Resolution ratifying the chart of accounts and project strings established by the Executive and the Fiscal Officer upon the conversion from the Banner system to the Tyler 8 9 Enterprise system as set forth in Exhibit A, for the Executive and the Fiscal Officer, and 10 declaring an emergency. 11 12 WHEREAS, this Council previously adopted Resolution 2021-325, authorizing the 13 Executive to enter into an agreement with Tyler Technologies for the purchase of the Munis ERP (now known as Tyler Enterprise) in order to replace the Banner, Kronos and PeopleAdmin 14 15 systems; and 16 17 WHEREAS, the Executive and the Fiscal Officer determined that the conversion from 18 Banner to Tyler Enterprise would occur in the first phase; and 19 WHEREAS, this conversion required the adoption of a new chart of accounts that 20 included project strings rather than a structure of funds, orgs and accounts; and 21 22 WHEREAS, the Executive desires to have Council confirm the new account and project 23 string structure, which is set forth in Exhibit A, a copy which is attached hereto and incorporated 24 fully herein, and contains a comparison to the prior structure embedded in Banner; and 25 26 WHEREAS, this Council has determined by reviewing all pertinent information that 27 confirming the account and project string structure incorporated into the Tyler Enterprise system 28 is necessary and in the best interest of the County of Summit; 29 30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State 31 of Ohio, that: 32 33 **SECTION 1** 34 35 The account and project string structure set forth in Exhibit A, a copy which is attached 36 hereto and incorporated fully herein, is confirmed as the correct structure for the purposes of 37 accurately accounting for the revenue and expenses of the County of Summit. 38 39 **SECTION 2** 40 41 The Fiscal Officer is authorized to establish the funds set forth in Exhibit A, a copy 42 which is attached hereto and incorporated fully herein. 43 44 **SECTION 3** 45 This Resolution is hereby declared an emergency in the interest of the health, safety and 46 47 welfare of the residents of the County of Summit and for the further reason that it is necessary to 48 confirm the account and project string structure utilized within the Tyler Enterprise system. 49 50 51
