A Resolution approving the award of the Board of Control of a Land Lease Agreement with Crown Castle, LLC, as a Best Practical Source, for a cell tower at 1100 North Avenue, Tallmadge, Ohio, in Council District 6, for a five-year term with four options to renew for additional five-year terms, for \$36,000.00 for the first year with a yearly 3% increase each year thereafter, and 25% of any the rental proceeds received by Crown Castle, LLC from users or sublessees, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, the Executive wishes to enter into a land lease agreement with Crown Castle, LLC for a cell tower located at 1100 North Avenue, Tallmadge, Ohio, in Council District 6. Crown Castle, LLC will pay the County rent for the tower and a 25% share of the rent for any users, excluding Crown Castle's current contract with Verizon; and

WHEREAS, Crown Castle, LLC is a Best Practical Source pursuant to Section 177.07(a)(5) of the Codified Ordinances of the County of Summit as they have several such leases with the County and are aware of the County's requirements for cell towers; and

WHEREAS, the Board of Control, at its meeting held July 19, 2023, awarded a Land Lease Agreement with Crown Castle, LLC, as a Best Practical Source, for a cell tower located at 1100 North Avenue, Tallmadge, Ohio, in Council District 6, for a five-year term with four options to renew for an additional five-year term, for \$36,000.00 for the first year with a yearly 3% increase each year thereafter, and 25% of any the rental proceeds received by Crown Castle, LLC from any users or sublessees, except current sublessee Verizon, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned land lease agreement with Crown Castle, LLC is necessary and in the best interest of the County of Summit; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;
