7 **A Resolution declaring the month of October 2023 as Safe Sleep and SIDS Awareness Month,**
8 **highlighting the risk of Sudden Infant Death Syndrome (“SIDS”) among infants, the**
9 **importance of safe sleep practices in reducing SIDS, and uplifting families with newborns,**
10 **for the Executive, and declaring an emergency.**

11

12 WHEREAS, Sudden Infant Death Syndrome (“SIDS”) is defined as the sudden and
13 unexpected death of an infant due to natural or unnatural causes where all other possible causes of
14 sudden unexplained death have been ruled out, and is the leading cause of death among infants
15 between 1 month and 1 year old; and

16

17 WHEREAS, Sudden Unexpected in Infancy (“SUDI”) is defined as a broader category of
18 unexplained deaths that lack the investigatory rigor of SIDS but still include unexpected,
19 unexplained deaths among infants; and

20

21 WHEREAS, SUDI accounted for an estimated 3,200 infant deaths in 2020, including 1,389
22 directly attributable to SIDS, according to the Centers for Disease Control and Prevention; and

23

24 WHEREAS, safe sleep practices, including always placing babies on their backs, removing
25 all toys, pillows, blankets, and bumpers, prioritizing sleep in a crib, and using a pacifier at nap or
26 bedtime, can all help prevent SIDS and other health risks; and

27

28 WHEREAS, educating parents and families in Summit County is crucial to preventing
29 SIDS and other health risks; and Full Term First Birthday is a collective impact collaborative
30 advocating for policies, educating our community, and informing our Greater Akron residents
31 about programs that promote healthy, full-term pregnancies and ensure every child celebrates a
32 first birthday; and

33

34 WHEREAS, through the use of data-driven initiatives, evidence/community-based
35 practices and community voice the Full Term First Birthday collaborative is dedicated to
36 increasing awareness and the elimination of unsafe sleep in Summit County; and

37

38 WHEREAS, infant health is of major importance to the overall health and wellbeing of
39 families in Summit County; and

40

41 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
42 that it is necessary and in the best interest of the County of Summit that October 2023 be declared
43 Safe Sleep and SIDS Awareness Month in Summit County, and encouraging the residents of
44 Summit County to join in this acknowledgement;

46 NOW, THEREFORE BE IT RESOLVED by the Council of the County of Summit, State

12 This Resolution is hereby declared an emergency in the interest of the health, safety and
13 welfare of the residents of the County of Summit, and for the further reason to immediately declare
14 October 2023 as Safe Sleep and SIDS Awareness Month in Summit County.

16 SECTION 3

18 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
19 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
20 be in force at the earliest time provided by law.

22 SECTION 4

24 It is found and determined that all formal actions of this Council concerning and relating
25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
26 deliberations of this Council and of any of its committees that resulted in such formal action, were
