<u>An Amended</u> Resolution confirming the award by the Board of Control of a professional service contract with VitalCore Health Strategies, LLC to provide jail inmate medical services, for a three-year term, from 1/1/24 12/1/23 through 12/31/26 11/30/26, with two options to renew for additional three-year terms, in a total amount not to exceed \$9,083,078.39, for the Sheriff, and declaring an emergency.

WHEREAS, subsequent to a Request for Proposals and review of four submissions including interviews, the County has selected VitalCore Health Strategies, LLC to provide jail inmate medical services, for the period 1/1/24 12/1/23 through 12/31/26 11/30/26, with two options to renew for additional three-year terms; and

WHEREAS, the cost of the aforementioned jail inmate medical services to be provided by VitalCore Health Strategies, LLC will be an amount not to exceed \$2,951,885.66 for year one, an amount not to exceed \$3,026,942.23 for year two, and an amount not to exceed \$3,104,250.50 for year three, for a total amount not to exceed \$9,083,078.39, for the three-year term of the contract; and

WHEREAS, the Board of Control, at its meeting held September 20, 2023, awarded a professional service contract with VitalCore Health Strategies, LLC to provide jail inmate medical services, for a three-year term, from $\frac{1}{1/24}$ $\frac{12}{1/23}$ through $\frac{12}{31/26}$ $\frac{11}{30/26}$, with two options to renew for additional three-year terms, in a total amount not to exceed \$9,083,078.39, subject to confirmation by this Council; and

WHEREAS, this Council has determined by reviewing all pertinent information that the aforementioned professional service contract with VitalCore Health Strategies, LLC is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a professional service contract with VitalCore Health Strategies, LLC to provide jail inmate medical services, for a three-year term, from 1/1/24 12/1/23 through 12/31/26 11/30/26, with two options to renew for additional three-year terms, in a total amount not to exceed \$9,083,078.39, for the three-year term of the contract, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any other necessary related documents.
