7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with SACS Consulting & Investigative Services to provide armed security guard**
9 **services at the Summit County Veterans Service Commission, located at 1060 E. Waterloo**
10 **Road, in the City of Akron, in Council District 6, for a one-year term, for the period 1/2/24**
11 **to 12/31/24, in an amount not to exceed \$74,400.00, for the Executive, and declaring an**
12 **emergency.**

14 WHEREAS, the Summit County Veterans Service Commission requires armed security
15 services for its building located at 1060 E. Waterloo Road, located in the City of Akron, in
16 Council District 6; and

17

18 WHEREAS, the Summit County Veterans Service Commission wishes to contract with
19 SACS Consulting & Investigative Services; and

20

21 WHEREAS, said contract will include security presence at the facility, walking/driving
22 tours of the facility, surveillance, customer service, proper training and certification, prevention
23 of theft, and additional designated duties; and

25 WHEREAS, SACS Consulting & Investigative Services maintains a level of
26 professionalism, dependability, and training that meets the Ohio Department of Public Safety
27 standards; and

29 WHEREAS, this contract is exempt under Section 177.07(a)(10) of the Codified
30 Ordinances, due to pricing that is the same or better than what other political subdivisions can
31 offer, as Summit County Veterans Service Commission sought quotes from the Summit County
32 Sheriff's Office and City of Akron Police Department; and

34 WHEREAS, the Board of Control, at its meeting held on November 8, 2023, awarded a
35 professional service contract for security services with SACS Consulting & Investigative
36 Services, in an amount not to exceed \$74,400.00, subject to confirmation by this Council; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that the aforementioned professional service contract with SACS Consulting & Investigative
40 Services is necessary and in the best interest of the County of Summit;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that;

47 The award by the Board of Control of a professional service contract with SACS
48 Consulting & Investigative Services to provide armed security guard services at the Summit
49 County Veterans Service Commission, located at 1060 E. Waterloo Road, located in the City of
50 Akron, in Council District 6, for a one-year term, for the period 1/2/24 to 12/31/24, in an amount
51 not to exceed \$74,400.00, is hereby confirmed and the Executive is hereby authorized to execute
52 said contract and any other necessary related documents.


