1 RESOLUTION NO. 2023-369 2 3 SPONSOR Executive Shapiro 4 5 DATE November 27, 2023 COMMITTEE Public Safety 6 7 A Resolution authorizing the Executive to execute the first of four intergovernmental renewal agreements with the City of Fairlawn and the Township of Bath to provide beds at 8 9 the County Jail for inmates, at a maximum of two inmates per day, for a term from 1/1/24 through 12/31/28, at a rate of \$158.79 per day per bed for the first year, with a rate 10 increase not to exceed 2.5% per year for each of the subsequent years, for the Executive's 11 12 Department of Law and Risk Management, and declaring an emergency. 13 14 WHEREAS, the County negotiated intergovernmental agreements with the City of 15 Fairlawn (the "City"), as authorized by Resolution No. 2019-047, and the Township of Bath (the "Township"), as authorized by Resolution No. 2019-075, to which the City and Township paid 16 for bed use in the Jail to house City and Township inmates, at a maximum of two inmates per 17 18 day per municipality, for a term from 1/1/19 through 12/31/23, with each party having four 19 options to renew, for five-year terms; and 20 21 WHEREAS, in 2019 the City and Township agreed to pay a rate of \$123.55 per day per 22 bed for the first year and a rate increase not to exceed 2.5% per year for each of the subsequent 23 years and this rate has not been increased; and 24 25 WHEREAS, the County has recently reviewed the costs of housing an inmate per day 26 and, in light of the rising costs of food, medical services and salaries, has determined that the 27 new cost is \$158.79 per day per bed; and 28 29 WHEREAS, this Council finds and determines, after reviewing all pertinent information 30 that it is necessary and the best interest of the County of Summit to authorize the Executive to 31 execute the aforementioned intergovernmental agreement renewals with the City of Fairlawn and 32 Township of Bath; 33 34 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State 35 of Ohio, that: 36 37 **SECTION 1** 38 39 The Executive is hereby authorized to execute intergovernmental agreement renewals 40 with the City of Fairlawn and Township of Bath to provide beds at the County Jail for City and Township inmates, at a maximum of two inmates per day, for a renewal term from 1/1/2441 42 through 12/31/28, at a rate of \$158.79 per day per bed for the first year and a rate increase not to 43 exceed 2.5% per year for each of the subsequent years, with such modifications and revisions as shall be in furtherance of the provisions of said intergovernmental agreements and not 44 45 substantially adverse to the County, all of which shall be conclusively evidenced by the 46 execution thereof by the Executive. 47 48 **SECTION 2** 49 50 This Resolution is hereby declared an emergency in the interest of health, safety and 51 welfare of the residents of the County of Summit, and for the further reason to immediately
