7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Perrin Asphalt Co., for the Paving Improvement Project, for the rear parking lot at the**
9 **Summit County Children Services Administration Building, located in the City of Akron,**
10 **in Council District 4, in an amount not to exceed \$137,500.00, for the Executive’s**
11 **Department of Administrative Services–Physical Plants, and declaring an emergency.**

13 WHEREAS, the Summit County Children Services Administration Building was built in
14 1996 and has only had repairs and resealing done to its parking lots since then; and

15

16 WHEREAS, this project will grind and overlay the rear parking lot to prolong the
17 serviceability of the building. The front parking lot improvement project was completed earlier
18 this year; and

20 WHEREAS, this Council previously adopted Resolution No. 2023-322, which authorized
21 the Executive to advertise for bids for the Paving Improvement Project, for the rear parking lot at
22 the Summit County Children Services Administration Building (the “Project”), located in the
23 City of Akron, in District 4, for a total not to exceed \$154,000.00; and

25 WHEREAS, after receiving five bids for the Project, the Executive selected Perrin
26 Asphalt Co. as the lowest responsive and responsible bidder with a bid of \$137,500.00; and

28 WHEREAS, the Board of Control, at its meeting held on November 29, 2023, awarded
29 the aforementioned construction contract with Perrin Asphalt Co., as the lowest responsive and
30 responsible bidder, for the Project, in an amount not to exceed \$137,500.00, subject to
31 confirmation by this Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information
34 that the aforementioned construction contract with Perrin Asphalt Co. is necessary and in the
35 best interest of the County of Summit;

37 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The award by the Board of Control of a construction contract with Perrin Asphalt Co. for
43 the Paving Improvement Project, for the rear parking lot at the Summit County Children Services
44 Administration Building (the “Project”), located in the City of Akron, in Council District 4, in an
45 amount not to exceed \$137,500.00, is hereby confirmed and the Executive is hereby authorized
46 to execute said construction contract and any other necessary related documents.
