A Resolution authorizing the Executive to execute the first of four intergovernmental renewal agreements with the City of Norton to provide beds at the Jail for City inmates, at a maximum of two inmates per day, for a term from 1/1/24 through 12/31/28, for a rate of \$158.79 per day per bed for the first year, with a rate increase not to exceed 2.5% per year for each of the subsequent years, for the Executive's Department of Law and Risk Management, and declaring an emergency.

WHEREAS, the County negotiated an intergovernmental agreement with the City of Norton, as authorized by Resolution No. 2019-074, to which the City paid for bed use in the Jail to house City inmates, at a maximum of two inmates per day, for a five-year term, with each party having four options to renew, for five-year terms; and

WHEREAS, in 2019 the City agreed to pay a rate of \$123.55 per day per bed for the first year and a rate increase not to exceed 2.5% per year for each of the subsequent years and this rate has not been increased; and

WHEREAS, the County has recently reviewed the costs of housing an inmate per day and, in light of the rising costs of food, medical services and salaries, has determined that the new cost is \$158.79 per day per bed; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and the best interest of the County of Summit to authorize the Executive to execute the aforementioned intergovernmental agreement renewal with the City of Norton;

NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Executive is hereby authorized to execute an intergovernmental agreement renewal with the City of Norton to provide beds at the Jail for City inmates, at a maximum of two inmates per day, for a renewal term from 1/1/24 through 12/31/28, for a rate of \$158.79 per day per bed for the first year and a rate increase not to exceed 2.5% per year for each of the subsequent years, with such modifications and revisions as shall be in furtherance of the provisions of said intergovernmental agreement and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the Executive.

SECTION 2

This Resolution is hereby declared an emergency in the interest of health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide beds at the County Jail needed by the City of Norton to house inmates.
