SECTION 1

The Executive is hereby authorized to execute the Eighth Amendment to the Master Services Agreement ("Master Agreement") with Energy Harbor, Corp., attached hereto as Exhibit A and incorporated herein as if fully restated, to supply electricity for the County's opt-out electric aggregation program pursuant to the Master Agreement for a one-year term, from 5/1/24 until 4/30/25, at an estimated fixed price of .0603/kWh. The Eighth Amendment is approved with changes therein not inconsistent with this Resolution and not substantially adverse to the County, which shall be approved by the Executive and conclusively evidenced by execution of the Eighth Amendment.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose of immediately authorizing the Executive to execute the Eighth Amendment to the Master Agreement upon the terms presently offered by Energy Harbor, Corp.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 4**
