1 RESOLUTION NO. 2024-043 2 3 SPONSOR <u>Executive Shapiro</u> 4 5 DATE February 12, 2024 COMMITTEE _____Public Works 6 7 A Resolution authorizing the Executive to execute a grant agreement with the Summit Soil and Water Conservation District in the amount of \$219,000.00 for services to the Surface 8 9 Water Management District and pursuant to the County's MS4 permit, for the Executive, 10 and declaring an emergency. 11 12 WHEREAS, this Council previously approved Resolution No. 2021-347, enacting 13 Chapter 944 of the Codified Ordinances of the County of Summit entitled "Illicit Discharge Detection and Elimination Program," to permit the Engineer to regulate non-stormwater 14 15 discharges to the storm water drainage system of the County; and 16 17 WHEREAS, this Council subsequently adopted Ordinance 2022-191, enacting Chapter 18 942 of the Codified Ordinances of the County of Summit which established the Surface Water 19 Management District ("SWMD"), and which authorized entering into contracts for services 20 necessary to accomplish the goals of the SWMD; and 21 22 WHEREAS, the Summit Soil and Water Conservation District ("SSWCD") has the 23 expertise necessary to provide services in conducting conservation programming, technical 24 assistance, community education, and illicit discharge detection in cooperation with the Summit 25 County Combined General Health District, all as part of the Minimum Control Measures 26 required under the County's MS4 permit and in furtherance of the SWMD; and 27 28 WHEREAS, the County has agreed to provide a grant to SSWCD in the amount of 29 \$219,000.00, for a twelve month period beginning with the signing of the grant agreement in 30 order for SSWCD to provide these necessary services, and a draft of the agreement is attached to 31 this legislation as Exhibit A and incorporated fully herein; and 32 33 WHEREAS, these grant funds will enable the SSWCD to obtain additional grant funds 34 from the State of Ohio in furtherance of this programming; and 35 36 WHEREAS, this Council finds and determines, after reviewing all pertinent information, 37 that it is necessary, and in the best interest of the County of Summit to authorize the Executive to 38 execute a grant agreement with the SSWCD; 39 40 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that: 41 42 43 **SECTION 1** 44 45 The Executive is hereby authorized to execute a grant agreement with the Summit Soil and Water Conservation District ("SSWCD") for a grant in the amount of \$219,000.00, for a 46 47 twelve month period in a form substantially similar to Exhibit A, a copy of which is attached 48 hereto and incorporated fully herein. 49 50 51 52
