7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Brite Computers, as a Best Practical Source, for the purchase of twenty-five (25) in-car**
9 **Getac computers, in an amount not to exceed \$112,500.00, for the Sheriff, and declaring an**
10 **emergency.**

11

12 WHEREAS, it is necessary to periodically upgrade and replace worn and/or out dated
13 equipment for use by the Sheriff’s Office; and

14

15 WHEREAS, this Council previously adopted Resolution No. 2024-028, which allocated
16 funds for replacement equipment purchases for the Sheriff as part of the Capital Improvements
17 Program for 2024-2029; and

18

19 WHEREAS, said purchase contract with Brite Computers includes mounts, docks,
20 keyboards and power supplies with the in-car computers; and

21

22 WHEREAS, pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified
23 Ordinances of the County of Summit, Brite Computers is a Best Practical Source as they
24 currently provide all of the Getac in-car computers and support equipment for the Sheriff’s
25 Office; and

27 WHEREAS, the Board of Control, at its meeting held March 6, 2024, awarded a purchase
28 contract, subject to the approval of the Information Technology Board, with Brite Computers, as
29 a Best Practical Source, for the purchase of twenty-five (25) in-car Getac computers, in an
30 amount not to exceed \$112,500.00, subject to confirmation by this Council; and

32 WHEREAS, the Information Technology Board, at its meeting held on March 7, 2024,
33 approved the aforementioned contact with Brite Computers; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that the aforementioned purchase contract with Brite Computers is necessary and in the best
37 interest of the County of Summit;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The award by the Board of Control of a purchase contract with Brite Computers,
45 approved by the Information Technology Board, as a Best Practical Source, for the purchase of
46 twenty-five (25) in-car Getac computers, in an amount not to exceed \$112,500.00, is hereby
47 confirmed and the Executive is hereby authorized to execute said purchase contract and any
48 other necessary related documents.
