WHEREAS, Section 177.08 further requires that said professional service contract, when in excess of \$75,000.00, must be approved by this Council; and

WHEREAS, the Board of Control, at its meeting held on March 13, 2024, awarded a professional service contract with Ward & Associates for countywide sexennial appraisal services for the valuation of all land and buildings for all commercial, industrial, and exempt and public utilities real estate in Summit County for proper taxation for tax year 2026, in an amount not to exceed \$848,000.00, subject to confirmation by this Council; and

 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Ward & Associates is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
