7 **A Resolution confirming the award by the Board of Control of a professional service**  
8 **contract with Burgess & Niple, Inc. for professional engineering design services for Project**  
9 **Q-208 Peninsula Wastewater Treatment and Sanitary Sewer System, located in the Village**  
10 **of Peninsula, in Council District 1, in an amount not to exceed \$1,409,800.00, funded by**  
11 **available American Rescue Plan Act funds, for the Executive’s Department of Sanitary**  
12 **Sewer Services, and declaring an emergency.**

13

14 WHEREAS, the County desires to undertake the Q-208 Peninsula Wastewater Treatment  
15 and Sanitary Sewer System Project, to provide sanitary sewer services to the residents of  
16 Peninsula due to failing septic systems (“Q-208 Project”) that will be funded by available  
17 American Rescue Plan Act funds, located in the Village of Peninsula, in Council District 1; and

19 WHEREAS, this Council previously adopted Resolution No. 2022-354, which authorized  
20 the Executive to execute a H2Ohio Standard Grant Agreement with the Ohio Environmental  
21 Protection Agency for the Q-208 Project; and

23 WHEREAS, the Executive sent request for proposals to forty-four engineering consulting  
24 firms and after reviewing the three submitted proposals, Burgess & Niple, Inc. was selected as  
25 the most qualified vendor; and

27 WHEREAS, the Board of Control, at its meeting held on April 24, 2024, awarded a  
28 professional service contract with Burgess & Niple, Inc., in an amount not to exceed  
29 \$1,409,800.00, subject to confirmation by this Council; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that it is necessary and in the best interest of the County to authorize the Executive to execute the  
33 aforementioned professional service contract with Burgess & Niple, Inc., in an amount not to  
34 exceed \$1,409,800.00;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

41 The award by the Board of Control of a professional service contract with Burgess &  
42 Niple, Inc. for engineering design services for Project Q-208 Peninsula Wastewater Treatment  
43 and Sanitary Sewer System (the “Project”), located in the Village of Peninsula, in Council  
44 District 1, in an amount not to exceed \$1,409,800.00, is hereby confirmed, and the Executive is  
45 hereby authorized to execute said professional service contract and any other necessary and  
46 related documents.

50 This Resolution is declared an emergency in the interest of the health, safety and welfare  
51 of the residents of the County of Summit and for the further reason to immediately provide for  
52 the engineering design services to allow the Project to proceed in a timely manner.
