7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **JD Stripping & Services, Inc. for the 2024 Regional Pavement Marking Program, in an**
9 **amount not to exceed \$281,177.50, for the Engineer, and declaring an emergency.**

10

11 WHEREAS, this Council previously adopted Resolution No. 2024-009, which authorized
12 the Executive to advertise for bridge engineering and construction projects, and pavement
13 maintenance projects, for the Engineer’s 2024 Capital Improvements Program, for an estimated
14 cost not to exceed \$10,720,000.00; and

15

16 WHEREAS, said projects were approved as part of the Capital Improvements Program
17 for 2024-2028 by Resolution No. 2024-028; and

18

19 WHEREAS, following the receipt and review of bids, the Executive proposes entering
20 into a construction contract with JD Stripping & Services, Inc., as the lowest responsive and
21 responsible bidder, for the 2024 Regional Pavement Marking Program, in an amount not to
22 exceed \$281,177.50; and

23

24 WHEREAS, the work to be performed by JD Stripping & Services, Inc. will be applying
25 pavement marking paint to various County, Copley, Bath Township, Sagamore Hills Township
26 and Twinsburg Township roads; and

27

28 WHEREAS, the contract total will be broken down by political subdivision as follows
29 with each subdivision responsible for directly paying the contractor:

30

- 31 County share: \$244,318.35
- 32 Copley: \$9,975.60
- 33 Bath Township: \$2,050.00
- 34 Sagamore Hills Township: \$6,753.30
- 35 Twinsburg Township: \$18,080.25; and

37 WHEREAS, the Board of Control, at its meeting held on May 8, 2024, awarded a
38 construction contract with JD Stripping & Services, Inc., as the lowest responsive and
39 responsible bidder, for the 2024 Regional Pavement Marking Program, in an amount not to
40 exceed \$281,177.50, subject to confirmation by this Council; and

41

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
43 that the aforementioned construction contract with JD Stripping & Services, Inc. for the 2024
44 Regional Pavement Marking Program is necessary and in the best interest of the County of
45 Summit;

47 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

6 The award by the Board of Control of a construction contract with JD Stripping &
7 Services, Inc. for the 2024 Regional Pavement Marking Program, in an amount not to exceed
8 \$281,177.50, is hereby confirmed and the Executive is hereby authorized to execute said
9 construction contract and any other necessary related documents.

13 This Resolution is hereby declared an emergency in the interest of the health, safety and
14 welfare of the residents of the County of Summit, and for the further purpose to immediately
15 provide necessary pavement marking to various County, Copley, Bath Township, Sagamore
16 Hills Township and Twinsburg Township roads in 2024.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
28 deliberations of this Council and of any of its committees that resulted in such formal action,
