7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Scodeller Construction, Inc. for the 2024 Summit County Regional Crack Sealing Program,**
9 **in an amount not to exceed \$131,338.84, for the Engineer, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2024-009, which authorized
12 the Executive to advertise for bridge engineering and construction projects, and pavement
13 maintenance projects, for the Engineer’s 2024 Capital Improvements Program, for an estimated
14 cost not to exceed \$10,720,000.00; and

15
16 WHEREAS, said projects were approved as part of the Capital Improvements Program
17 for 2024-2029 by Resolution No. 2024-028; and

18
19 WHEREAS, following the receipt and review of bids, the Executive proposes entering
20 into a construction contract with Scodeller Construction, Inc. for the 2024 Summit County
21 Regional Crack Sealing Program, in an amount not to exceed \$131,338.84; and

23 WHEREAS, the proposed work to be performed consists of preparing and sealing
24 pavement cracks with hot applied crack sealant per ODOT specification item No. 423 Crack
25 Sealing, Hot Applied, Type IV; and

27 WHEREAS, the contract total will be broken down by participating political subdivisions
28 as follows with each subdivision responsible for directly paying the contractor:

30 County share: \$65,298.78
31 Twinsburg Township: \$66,040.06; and

33 WHEREAS, the Board of Control, at its meeting held May 8, 2024, awarded a
34 construction contract with Scodeller Construction, Inc., as the lowest responsive and responsible
35 bidder, for the 2024 Summit County Regional Crack Sealing Program, in an amount not to
36 exceed \$131,338.84, subject to confirmation by this Council; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that aforementioned construction contract with Scodeller Construction, Inc. is necessary and in
40 the best interest of the County of Summit;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that;

47 The award by the Board of Control of a construction contract with Scodeller
48 Construction, Inc. for the 2024 Summit County Regional Crack Sealing Program, in an amount
49 not to exceed \$131,338.84, is hereby confirmed and the Executive is hereby authorized to
50 execute said construction contract and any other necessary related documents.


