7 **A Resolution setting the date for the Final Public Hearing and authorizing the**
8 **publication and legal notices for said hearing for the proposed public**
9 **improvement known as the Wye Road Flood Mitigation And Improvements**
10 **Project - Phase 2 located in Bath Township, pursuant to Section 6131.16 of the**
11 **Ohio Revised Code, for Council, and declaring an emergency.**

12
13 WHEREAS, a ditch petition was filed on March 6, 2024 pursuant to Section
14 6131.04 of the Ohio Revised Code requesting the County to repair the natural drainage
15 course, which has caused flooding due to major storms in recent years and install
16 measures to mitigate the erosive and flooding effect of future storms; and

17
18 WHEREAS, a public viewing took place April 10, 2024 in Bath Township, the
19 Engineer filed a Preliminary Report on April 29, 2024 and a public hearing took place
20 May 13, 2024 in Council Chambers in accordance with Section 6131.101 of the Ohio
21 Revised Code; and

23 WHEREAS, this Council on May 13, 2024 adopted Resolution No. 2024-148
24 granting design preparations for said project in accordance with Section 6131.12 of the
25 Ohio Revised Code; and

27 WHEREAS, the Engineer has proceeded with the design of said improvements
28 and prepared schedules and reports and has filed these with the Clerk of Council in
29 accordance with Section 6131.14 of the Ohio Revised Code; and

31 WHEREAS, this Council has determined, after reviewing all pertinent
32 information, that it is necessary and in the best interest of the County of Summit to
33 authorize the publication and legal notice of the Final Public Hearing for the proposed
34 public improvement located in Bath Township, pursuant to Section 6131.16 of the Ohio
35 Revised Code.

37 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of
38 Summit, State of Ohio, that:

42 Pursuant to Section 6131.16 of the Ohio Revised Code, a legal notice of a Final
43 Public Hearing shall be published one time in a newspaper of general circulation in
44 Summit County; individual notice to all owners of land which will be benefitted or
45 damaged by construction of the proposed improvement shall be sent by certified mail,
46 return receipt requested, giving notice that a Final Public Hearing will take place on
47 **Monday, June 24, 2024 at 4:30 pm in Council Chambers, Ohio Building – 7th Floor,**
48 **175 South Main Street, Akron, Ohio.**


