7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Pavement Technology, Inc. for the 2024 Summit County Regional Asphalt Rejuvenating**
9 **Program, in an amount not to exceed \$161,049.97, for the Engineer, and declaring an**
10 **emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2024-009, which authorized
13 the Executive to advertise for bridge engineering and construction projects, and pavement
14 maintenance projects, for the Engineer’s 2024 Capital Improvements Program, for an estimated
15 cost not to exceed \$10,720,000.00; and

16
17 WHEREAS, said projects were approved as part of the Capital Improvements Program
18 for 2024-2029 by Resolution No. 2024-028; and

19
20 WHEREAS, following the receipt and review of bids, the Executive proposes entering
21 into a construction contract with Pavement Technology, Inc., as the lowest responsive and
22 responsible bidder, for the 2024 Summit County Regional Asphalt Rejuvenating Program, in an
23 amount not to exceed \$161,049.97; and

25 WHEREAS, the proposed work consists of furnishing all labor, equipment. and material,
26 and performing all operations necessary for the rejuvenation and in-depth sealing of asphaltic-
27 concrete surface courses by spray application of a cationic rejuvenating agent composed of
28 petroleum oils and resins emulsified with water in accordance with the specifications and terms
29 of the contract; and

31 WHEREAS, the contract total will be broken down by political subdivision as follows
32 with each subdivision responsible for directly paying Pavement Technology, Inc.:

34 County share: \$125,687.13
35 Twinsburg Twp.: \$35,362.84; and

37 WHEREAS, the Board of Control, at its meeting held May 29, 2024, awarded a
38 construction contract with Pavement Technology, Inc., as the lowest responsive and responsible
39 bidder, for the 2024 Summit County Regional Asphalt Rejuvenating Program, in an amount not
40 to exceed \$161,049.97, subject to confirmation by this Council; and

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
43 that aforementioned construction contract with Pavement Technology, Inc. is necessary and in
44 the best interest of the County of Summit;

7 Inc. for the 2024 Summit County Regional Asphalt Rejuvenating Program, in an amount not to

9 construction contract and any other necessary related documents.

21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.
