7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with Burgess & Niple, LLC. for design services for the rehabilitation of the**
9 **Wheatley Road Bridge over Riding Run, located in Richfield Township, in Council District**
10 **5, in an amount not to exceed \$121,223.00, for the Engineer, and declaring an emergency.**

11

12 WHEREAS, the rehabilitation of the Wheatley Road Bridge will include removal of the
13 structurally deficient, load posted, single span concrete slab bridge over Riding Run. The
14 proposed bridge will provide a new single span concrete slab bridge and re-use the existing
15 abutments (the “Project”); and

16

17 WHEREAS, this Council previously adopted Resolution No. 2024-009, which authorized
18 the Executive to advertise, as needed, for bridge engineering and construction projects, and
19 pavement maintenance projects, for the Engineer’s 2024 Capital Improvements Program, and
20 federal and state funded projects, for an estimated total cost not to exceed \$10,720,000.00; and

22 WHEREAS, said projects were approved as part of the Capital Improvements Program
23 for 2024-2029 by Resolution No. 2024-028; and

25 WHEREAS, the Engineer requested qualifications from seven firms to perform the
26 design work, of which six responded; and

27

28 WHEREAS, after considering the six proposals, the Engineer recommends Burgess &
29 Niple, LLC. as the most qualified firm and the Engineer has negotiated the scope of services; and

31 WHEREAS, the Board of Control, at its meeting held on May 22, 2024, awarded a
32 professional service contract with Burgess & Niple, LLC. for design services for the
33 rehabilitation of the Wheatley Road Bridge over Riding Run, located in Richfield Township, in
34 Council District 5, in an amount not to exceed \$121,223.00, subject to confirmation by this
35 Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that the aforementioned professional service contract with Burgess & Niple, LLC, is necessary
39 and in the best interest of the County of Summit;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The award by the Board of Control of a professional service contract with Burgess &
47 Niple, LLC. for design services for the rehabilitation of the Wheatley Road Bridge over Riding
48 Run (the “Project”), located in Richfield Township, in Council District 5, in an amount not to
49 exceed \$121,223.00, is hereby confirmed and the Executive is hereby authorized to execute said
50 professional service contract and any other necessary related documents.

14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,

22 121.22 of the Ohio Revised Code.

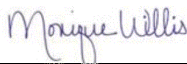
