7 **A Resolution authorizing the County to enter into a contract with Summit County**  
8 **Children Services for policing and after-hours call answering services to be performed by**  
9 **the Sheriff’s Office for the period 7/1/24 through 6/30/25, in an amount not to exceed**  
10 **\$181,185.64, for the Executive and the Sheriff, and declaring an emergency.**

11

12 WHEREAS, a Memorandum of Understanding between Summit County Children  
13 Services (“SCCS”), the Sheriff’s Office, the County of Summit Department of Job and Family  
14 Services and various police agencies was authorized by this Council on September 11, 2023  
15 through Resolution No. 2023-265; and

16

17 WHEREAS, the Sheriff’s Office has provided call answering services for SCCS  
18 historically, with the current contract expiring on 6/30/24; and

19

20 WHEREAS, SCCS and the Summit County Sheriff’s Office desire to enter into a  
21 contract, attached hereto as Exhibit A and incorporated herein, for policing and after-hours call  
22 answering services, in an amount not to exceed \$181,185.64; and

24 WHEREAS, SCCS has a duty to notify law enforcement of child abuse and neglect per  
25 Ohio Revised Code Section 2151.421(E)(2)(c) and desires Sheriff law enforcement officers to  
26 investigate such reports received while performing the after-hours call answering services; and

28 WHEREAS, this Council has determined that the Executive should be authorized to  
29 execute contracts for the Sheriff for these services at the rates previously authorized in  
30 Resolution No. 2023-313; and

31

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
34 execute a contract for policing and after-hours call answering services;

36 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

39 SECTION 1

40

41 The Executive is hereby authorized to execute a contract and any other necessary related  
42 documents with Summit County Children Services for policing and after-hours call answering  
43 services to be performed by the Sheriff’s Office for the period 7/1/24 through 6/30/25, in an  
44 amount not to exceed \$181,185.64. The contract will be in the substantially same form as Exhibit  
45 A, a copy of which is attached to this resolution and incorporated herein as if fully restated, with  
46 such modifications and revisions as shall be in furtherance of the provisions of said  
47 intergovernmental agreement and not substantially adverse to the County, all of which shall be  
48 conclusively evidenced by the execution thereof by the Executive.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the residents of the County of Summit, and for the further reason to immediately  
8 authorize services needed by Summit County Children Services and to authorize the Executive to  
9 execute a contract for services provided by the Sheriff and any necessary related documents.

11 SECTION 3

12

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

17 SECTION 4

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,  
22 were in meetings open to the public, in compliance with all legal requirements, including Section  
23 121.22 of the Ohio Revised Code.




