7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **The Ohio Desk Company, at State Term Pricing, for new office furniture for the Psycho-**
9 **Diagnostic Clinic, for a total amount not to exceed \$140,349.26, for the Court of Common**
10 **Pleas, and declaring an emergency.**

11

12 WHEREAS, the Psycho-Diagnostic Clinic, which completes assessments and evaluations
13 for court referred individuals, located in the Summit County Courthouse, is in need of new office
14 furniture for both staff and clients; and

15

16 WHEREAS, the Executive recommends entering into a purchase contract with The Ohio
17 Desk Company, at State Term Pricing, for new office furniture for the Psycho-Diagnostic Clinic,
18 for a total amount not to exceed \$140,349.26; and

20 WHEREAS, the funds for the aforementioned office furniture purchase are available in
21 the current fiscal budget and the Psycho-Diagnostic Clinic is grant funded so no County monies
22 will be spent on this contract; and

24 WHEREAS, the Board of Control, at its meeting held on May 29, 2024, awarded a
25 purchase contract with The Ohio Desk Company, at State Term Pricing, for new office furniture
26 for the Psycho-Diagnostic Clinic, for a total amount not to exceed \$140,349.26, subject to the
27 confirmation of this Council; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned purchase contract with The Ohio Desk Company is necessary and in the
31 best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The award by the Board of Control of a purchase contract with The Ohio Desk Company,
39 at State Term Pricing, for new office furniture for the Psycho-Diagnostic Clinic, for a total
40 amount not to exceed \$140,349.26 is hereby confirmed, and the Executive is hereby authorized
41 to execute said purchase contract and any other necessary related documents.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the residents of the County of Summit, and for the further reason to immediately
47 provide the Psycho-Diagnostic Clinic with new office furniture to create a better professional
48 environment for both the Clinic's staff and clients.


