7 **A Resolution declaring the day of August 24, 2024 as Summit County Pride Day, encouraging**
8 **residents to celebrate and support the LGBTQ+ community and the Akron Pride Festival**
9 **and Equity March, for the Executive, and declaring an emergency.**

11 WHEREAS, the LGBTQ+ community has seen significant progress in advancing equality
12 and equity for people of all sexualities and genders, including accomplishments like the
13 decriminalization of LGBTQ+ identities, protections against discrimination on the basis of
14 sexuality in the workplace, and the landmark ruling on marriage equality; and

15

16 WHEREAS, the LGBTQ+ community continues to see barriers old and new to achieving
17 full equality, equity, and acceptance in society, especially in relation to the rights of trans and non-
18 binary people to participate fully in public life; and

19

20 WHEREAS, LGBTQ+ people are disproportionately more likely to experience anxiety and
21 depression than their heterosexual counterparts, and Black, Latino, and indigenous LGBTQ+
22 people face multi-faceted forms of discrimination that continue to make housing, employment,
23 and services more difficult to attain; and

25 WHEREAS, pride is a tradition forged in solidarity, liberation, and celebration where
26 LGBTQ+ people and their allies join in protest and performance to reject the status quo and grow
27 their vision for a more just, more equal society; and

29 WHEREAS, the Akron Pride Festival is an annual celebration observed in August to unify
30 and affirm the LGBTQ+ people and allies to advance diversity, equality, and acceptance in the
31 community; and

33 WHEREAS, numerous residents, organizations, and businesses donate their time, talent,
34 and financial support to ensure the Akron Pride Festival is a success; and

35

36 WHEREAS, the County of Summit is committed to fostering a community where all
37 residents and all families are safe and accepted so that they may thrive; and

39 WHEREAS, the County of Summit is proud to support the annual Akron Pride Festival,
40 which attracts people from around the region to celebrate and enjoy the march, shows, vendors,
41 and more; and

43 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
44 that it is necessary and in the best interest of the County of Summit that August 24, 2024, be
45 declared Summit County Pride Day, encouraging residents to celebrate and support the LGBTQ+
46 community and the Akron Pride Festival and Equity March;

48 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
49 of Ohio, that:

6 August 24, 2024 is hereby declared Summit County Pride Day in Summit County, and the
7 residents of Summit County are encouraged to join in this acknowledgement.

11 This Resolution is hereby declared an emergency in the interest of the health, safety, and
12 welfare of the residents and employees of the County of Summit and for the further purpose of
13 immediately declaring August 24, 2024, as Summit County Pride Day in Summit County.

15 SECTION 3

17 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take
18 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
19 and be in force at the earliest time provided by law.

21 SECTION 4

23 It is found and determined that all formal actions of this Council concerning and relating
24 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
25 deliberations of this Council and of any of its committees that resulted in such formal action, were
26 in meetings open to the public, in compliance with all legal requirements, including Section 121.22
27 of the Ohio Revised Code.


