7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **MAC Trailer Mfg., Inc. for a Tri-Axle Dump Trailer in an amount not to exceed**
9 **\$83,701.00, for the Executive’s Department of Sanitary Sewer Services, and declaring an**
10 **emergency.**

12 WHEREAS, the Executive’s Department of Sanitary Sewer Services (“DSSS”) desires to
13 enter into a purchase contract with MAC Trailer Mfg., Inc. (“MAC Trailer”) to purchase a new
14 Tri-Axle Dump Trailer for the hauling of sludge and to transport materials during sewer mainline
15 repairs and rehabilitation projects; and

17 WHEREAS, this Council previously adopted Resolution No. 2024-075, which authorized
18 the Executive to advertise for bids for a Tri-Axle Dump Trailer, for an estimated total cost not to
19 exceed \$88,000.00; and

21 WHEREAS, the Board of Control, at its meeting held on June 5, 2024, awarded a
22 purchase contract with MAC Trailer, as the lowest responsive and responsible bidder, for a Tri-
23 Axle Dump Trailer in an amount not to exceed \$83,701.00, subject to confirmation by this
24 Council; and

26 WHEREAS, this Council finds and determines after reviewing all pertinent information
27 that the aforementioned purchase contract with MAC Trailer is necessary and in the best interest
28 of the County of Summit;

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

33 SECTION 1

35 The award by the Board of Control of a purchase contract with MAC Trailer Mfg., Inc.,
36 as the lowest responsive and responsible bidder, for a Tri-Axle Dump Trailer, in an amount not
37 to exceed \$83,701.00, is hereby confirmed and the Executive is hereby authorized to execute
38 said purchase contract and any other necessary related documents.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit, and for the further reason to immediately
44 authorize the purchase of necessary equipment for use by the Executive’s Department of
45 Sanitary Sewer Services.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
