7 **A Resolution approving and authorizing the Executive to execute and submit the**
8 **Community Development Block Grant and HOME Investment Partnership Program 2024**
9 **Action Plan to the U.S. Department of Housing and Urban Development for program year**
10 **2024 and authorizing the Executive to execute the 2024 Community Development Block**
11 **Grant and HOME Investment Partnership Program contracts, for the Executive’s**
12 **Department of Community and Economic Development, and declaring an emergency.**

13

14 WHEREAS, as a prerequisite for receiving Community Development Block Grant
15 (“CDBG”) and Home Investment Partnership Program (“HOME”) funding for program year
16 2024, the County is required to submit a 2024 Action Plan to the U.S. Department of Housing
17 and Urban Development (“HUD”) by August 16, 2024; and

18

19 WHEREAS, the County of Summit anticipates receiving \$980,634.00 in CDBG funding
20 and \$362,324.00 in HOME funding for the 2024 program year; and

21

22 WHEREAS, CDBG and HOME Programs will serve low to moderate income individuals
23 or low to moderate income areas in the Summit County jurisdiction; and

24

25 WHEREAS, the County of Summit CDBG Review Committee has reviewed and
26 approved the 2024 CDBG projects and recommended project funding for the activities set forth
27 in Exhibit A, which is attached hereto and incorporated herein as if fully restated; and

29 WHEREAS, the Department of Community and Economic Development has prepared
30 the 2024 Action Plan for CDBG and HOME programs, which is due to HUD by August 16,
31 2024; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information
34 that it is necessary and in the best interest of the County of Summit to approve and authorize the
35 Executive to execute and submit the 2024 Action Plan for the CDBG and HOME activities to
36 HUD;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 The Executive is hereby authorized to execute and submit the 2024 Action Plan to the
44 U.S. Department of Housing and Urban Development (“HUD”) for the 2024 program year for
45 Community Development Block Grant (“CDBG”) and Home Investment Partnership Program
46 (“HOME”) federal funding awards; said 2024 Action Plan activities shall include the activities as
47 set forth in Exhibit A, which is attached hereto and incorporated herein as if fully restated.

9 by the August 16, 2024, deadline and to immediately facilitate CDBG and HOME funding for
10 the program year 2024.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.


