## **SECTION 1**

The subdivision, which shall be known as "Heartridge Subdivision Phase 2", located in Sagamore Hills Township, in Council District 1, together with restrictions, covenants and easements thereon, is hereby approved and accepted by the County of Summit, to be recorded by the Fiscal Officer.

## **SECTION 2**

The following performance bonds furnished by <u>Ohio Farmers Insurance Company</u>, in the total amount of <u>\$ 1,199,923.18</u>, having been submitted and approved, were accepted in conjunction with "Heartridge Subdivision Phase 2". The documents are to be retained by the Executive, who is authorized to release said bond, in part or in full, upon satisfactory completion of the obligations set forth.

## **SECTION 3**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason that it immediately facilitates development in Sagamore Hills Township, in Council District 1.

## **SECTION 4**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
